I hold Fantasy Cruises and their crew harmless for any reactions that may occur from taking any medications in their efforts to assist me. In the event of an allergic reaction that escalates to an emergency, I authorize Fantasy Cruises to utilize an EpiPen to treat such reaction. I am in full agreement that I am releasing Fantasy Cruises of any medical and additional responsibilities.
